Dr. Susan Adams called the July 18, 2023 Board of Directors meeting to order at 3:38PM.

Dr. Adams proposed the approval of the May 16, 2023 minutes. Ms. Susan Vogt made the motion to approve the minutes. Mrs. Ashley Acuff seconded the motion. Motion was approved.

### Finance:

Mr. Brian Anderson gave an update on the financials including where the organization finished the fiscal year. The organization was about \$415,000 above budget. Mr. Anderson anticipates year-end financials to be available in August. The organization will continue to work with the same firm for the annual audit and the engagement letter was just received, meaning the audit will soon be scheduled.

### **Academic Update**

Mrs. Dana Larson gave an overview of the school's State Assessment data for 22-23. Thomas Gregg's scores continue to trend positively. Per board request, we will have more details to share regarding ILEARN scores for TGNS grade bands and scores for similarly situated schools.

#### **Operations**

Mrs. Anuja Petruniw gave an enrollment summary as of July 17, 2023. We are currently at 537 students at TGNS and 329 students at WINS. Enrollment at both sites will continue to grow and fluctuate as more K students enroll.

Ms. Petruniw gave an update on the personnel report. 12 new hires across both schools along with a few resignations. Of 122 NEISC positions, 110 are filled. We continue to work to fill vacant positions at both TGNS and WINS.

### **Resource Development**

Mr. Pippin shared that the organization received a grant from Corteva to support pond clean-up at WINS.

Mr. Pippin gave an update to the board regarding board assessment and shared context around the need. Mr. Pippin sought feedback from the members around the questions presented.
